NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.
- 1.3 For protests where a Rule of Part 2 or Rule 31 is alleged to have been broken an arbitration hearing will be offered prior to any formal hearing.

2 ADVERTISING

Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to all boats of the R Class Skiff class that comply with the class rules.
- 3.2 Eligible boats may enter by completing the attached form and sending it, together with the required fee, to Secretary, Naval Point Club Lyttelton, by 09.30 hours on Friday 19th February 2016.
- 3.3 To be eligible to compete in this event each entrant and crew member shall be a financial member of a club recognised by the entrant and crew member's national authority.
- 3.4 Each entrant and crew member shall be a financial member of an R Class Squadron.

4 FEES

Contest Entry Fee: To be advised by 09.30 hours on Friday 19th February 2016; it is expected that the fee will be \$175 per boat for those sailing 3 days; and \$150 for those sailing 2 days.

5 SCHEDULE

- 5.1 Registration:
 - Friday 19th February 2016, from 0800 hrs to 0930 hrs at Naval Point Club Lyttelton.
- 5.2 Briefing will be on Friday 19th February from 0930 hrs at Naval Point Club Lyttelton.
- 5.3 The scheduled time of the warning signal for the Invitation Race and Race 1 of the championship is 11.00 hrs on Friday 19th February 2016.
- 5.4 The scheduled time of the warning signal for Race 2 of the championship is 14.00 hrs on Friday 19th February 2016.
- 5.5 Up to three races, with a maximum of two races back to back, are scheduled per day.
- 5.6 A total of nine races are scheduled.
- 5.7 The scheduled time of the warning signal for the first race on Saturday and Sunday is 11.00 hrs

MEASUREMENTS

Each boat shall produce a valid measurement certificate and in addition measurement checks may be made.

7 SAILING INSTRUCTIONS

The sailing instructions will be available at registration and draft Sailing Instructions will be available on the Naval Point Club Lyttelton website www.navalpoint.co.nz

8 VENUE

- 8.1 Attachment A shows the location of the regatta venue.
- 8.2 Attachment B shows the location of the racing areas.

9 THE COURSES

The courses to be sailed will be Windward Leeward; two laps. The bottom mark/ finish mark will be to the starboard of the committee boat.

Boats that have completed only one lap after the first boat has finished (i.e., have

been lapped by the leading boat), will be finished at the end of that lap. Points will be awarded in position sequence after the boats that complete the full course.

10 SCORING

- 10.1 The scoring system awards points according to the formula 400/ (N+3) where N is the official finishing position of a boat.
- 10.2 Five races will be required to be completed to constitute a series.
- 10.3 No score will be excluded.

11 SUPPORT BOATS

- 11.1 Support boats will be allowed.
- 11.2 Support boats must be registered with the Organising Authority at registration.

12 LAUNCHING

Unless otherwise directed by the Organising Authority, all competing boats and equipment shall be launched and retrieved from Naval Point Club Lyttelton.

13 RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.


Attachment A Venue Location in Lyttelton
